Such parties are great but what I would encourage management to add to their Christmas party are the lasting gifts that will keep on making a difference with their staff for years to come.

The first gift is "The Daily Thank You!" Studies have concluded that the most important practice of effective managers is to provide a genuine "thank you" to each staff member, making sure that it is

daily, sincere and specific as to why. One example of such a gesture comes from a business owner in the Baltimore area, who puts ten dimes in his left pant pocket that reminds him to provide at least ten "thank you" comments prior to lunch. He passes a dime to his other pocket with each "thank you" and he doesn't get to take lunch until all ten dimes have been transferred. He repeats this same process in the afternoon.

The second gift appreciated most by staff is constant two-way communication with their supervisor. As we all have been told, it is good communication that keeps relationships strong and this principle is high on the list within all organizations. Staff has the right to know what goes on within the organization. Management must create avenues for people to communicate with one another and just as important is conducting quarterly reviews with staff to establish formal records of performance. Such structure is a necessity.

The third gift of value to staff is the opportunity to grow within their responsibilities. Management must be diligent to pro-

vide staff with assignments that they can develop from while achieving goals for the organization. Such opportunities need to be well thought out and then introduced each quarter during the quarterly review. Once provided, managers become coaches, monitoring the progress by each staff member. A special note here is that this is really a two-way gift, because management benefits by identifying which staff members hold potential for promotion.

The fourth and final gift to staff is a good boss! Here I speak out on image, which is what people derive from our character. A common desire of staff is to be part of a winning organization, noting that winning organizations result from high caliber people doing great things. The type of managers that staff benefit from and enjoy being associated are those who are reliable; they walk their talk. In addition, good managers are great listeners, always seeking the opinions of others and responding to what is communicated. Finally, great managers are honest, and live to biblical standards of morality and ethics.
